3. PURPOSE. This Mortgage and the Obligations described him in are executed and incurred for consumer purposes.

4. FUTURE ADVANCES AND EXPENSES. This Mortgage secures the repayment of all advances that Lender may extend to Borrower or Grantor under the promissory notes and other agreements evidencing the revolving crerul hans described in paragraph 2.
