of nine hundred eight dollars and 55/100 Dollars.

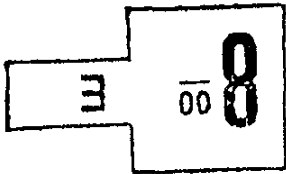

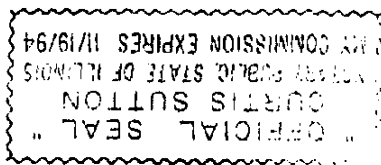
