Loan Act of 1933 ("HOLA"), appointed the Resolution Trust Corporation as Conservator for New Great American,

WHEREAS, the Receiver transferred the assets and certain liabilities of Old Great American to New Great American,
including certain Mortgages Deed of trust which are subject to this Assignment, pursuant to a Purchase and
Assumption Agreement dated May 25, 1990;

WHEREAS, on September 21, 1990, the OTS, by order No. 90-1750 and 90-1749, appointed the Resolution Trust
Corporation as the Receiver for New Great American.
