WHEREAS on May 25, 1990, the OTS by order numbers 90-915, chartered Great American Savings and Loan Association.
("New Great American") as a federal mutual savings bank, and pursuant to Section 5(d)(2)(B)(i) of the Home Owners
Loan Act of 1933 ("HOLA"), appointed the Resolution Trust Corporation as Conservator for New Great American;
WHEREAS, the Receiver transferred the assets and certain liabilities of Old Great American to New Great American,
including certain Mortgages Deed of trust which are subject to this Assignment, pursuant to a Purchase and
Assumption Agreement dated May 25, 1990;
WHEREAS, on September 21, 1990, the OTS, by order No. 90-1750 and 90-1749, appointed the Resolution Trust
Corporation as the Receiver for New Great American.
