**INSTALLMENT NOTE
AND
TRUST DEED MODIFICATION AGREEMENT**

THIS MODIFICATION AGREEMENT made and entered into as of the 1st day of September, 1991, by and between Christine A. Irwin (herein called the "Borrower") and NBD Chicago Bank, a banking association (herein called the "Bank").

WITNESSETH That:

WHEREAS, the Borrower has heretofore executed and delivered to the Bank a certain Installment Note (herein called the "Original Note"), dated 7/31/84, in the principal sum of Fifty Five Thousand and 00/100 Dollars (\$ 55,000.00) payable to the order of the Bank which Original Note evidenced (herein called the "Loan") from the Bank to the benefit of Borrower; and

WHEREAS, Lender is the holder and owner of the Original Note and is the Mortgagee under a Trust Deed hereinafter referred to; and

WHEREAS, to secure the Original Note, Borrower heretofore executed and delivered a Trust Deed dated 7/31/84, and recorded 8/8/84 as Document No. 27206686 in the Office of the Recorder of Cook County, Illinois, described as follows:

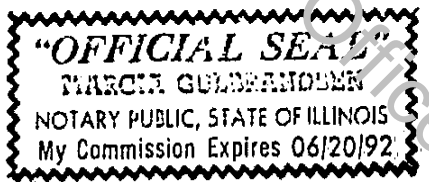
