Boulevard, Apt. 3B, Fort Myers Beach, Florida.





THAT THE SAID GRANTOR, for and in consideration of the sum

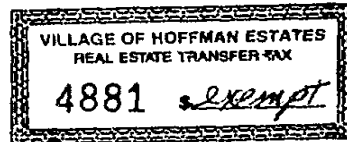
