1. That on May 9, 1991, the Owner owned the property legally described as follows: Lot 16 in South Barrington Green, a subdivision of part of the East 1/2 of the S.E. 1/4 of Section 22, and part of the E. 1/2 of the N.E. 1/4 of Section 27, in Township 42 North, Range 9 East of the Third Principal Meridian, in Cook County, Illinois, commonly known as 7 Beachnut Drive, South Barrington, Illinois 60010 P.I.N. 01-22-401-016.
2. That on May 9, 1991, the Claimant made a contract with said Owner to clean, repair and stain wood siding, deck and screen porch areas for \$3,450.00.
2. That all work contracted for was completed in August, 1991.
3. That said Owner has made partial payment to Claimant, leaving a balance due, unpaid and owing to the Claimant of \$2,600.00 for which with interest, the Claimant claims a lien on said land and improvements.


