UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.
- 2. Funds for Taxes and Insurance. - 6. Occupancy, Preservation, Maintenance and Protection of the Property; Borrower's Loan Application; Leaseholds. Borrower shall occupy, establish, and use the Property as Borrower's principal residence within sixty days after the execution of this Security Instrument and shall continue to occupy the Property as Borrower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate, or commit waste on the Property. October , 19 91 THIS PLANNED UNIT DEVELOPMENT RIDER is made this 28th day of and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security instrument") of the same date, given by the undersigned (the "Borrower") to secure the Borrower's Note to ICM MORTGAGE CORPORATION, a Delaware Corporation (the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 4580 JADE LANE, HOFFMAN ESTATES, ILLINOIS 60195

[Property Address]

The Property includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in COVENANTS AND RESTRICTIONS CONTAINED IN THE DECLARATION RECORDED AS DOCUMENT NUMBER 86-249154, RELATING TO THE CREATION OF CASTLEFORD HOMEOWNERS ASSOCIATION

(the "Declaration"). The Property is a part of a planned unit development known as: HEART/ISTONE UNIT 2

(the "PUD"). The P operty also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and racillties of the PUD (the "Owners Association") and the uses, benefits and proceeds of Borrower's Interest.

PUD COVENANTS in addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- A. PUD Obligations. Borrower shall perform all of Borrower's obligations under the PUD's Constituent Documents, The "Constituent Documents" are the (i) Declaration; (ii) articles of Incorporation, trust instrument or any equivalent document which creates the Owners Association, and (III) any by-laws or other rules or regulations of the Owners Association. - (I) Lender waives the provision in Uniform Covenant 2 for the monthly payment to Lender of the yearly premium installments for hazard insurance on the Property; and

- In the event of a distribution of hazard insurance proceeds in life of restoration or repair following a loss to the Property, or to common areas and facilities of the PUD, any proceeds payable to Eoriower are hereby assigned and shall be paid to Lender. Lender shall apply the proceeds to the sums secured by the Security instrumer., with any excess paid to Borrower.
- C. Public Liability Insurance. Borrower shall take such actio is as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount and extent of coverage to Lender.
- D. Condemnation.
