SECTION 3. The vacation herein provided for is made upon the express condition that within 90 days after the passage of this ordinance, the Parkway Bank and Trust Company, as Truster, Trust No. 8935 and Trust No. 3283 shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps.

SECTION 4. This ordinance shall take effect and be in force from and after its passage.


