All of the foregoing are deemed to be a part of said premises, whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by Trustors or their successors or assigns shall be considered as constituting parts of the premises.

TO HAVE AND TO HOLD the premises and fixtures, its successors and assigns, forever, for the purposes and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits, Trustors do hereby expressly release and waive.
