

MODIFICATION AND EXTENSION AGREEMENT

THIS AGREEMENT made this 14th day of August, 1991, between THE STEEL CITY NATIONAL BANK OF CHICAGO, a national banking association, hereinafter called First Party, and FIRST BANK OF OAK PARK, Trustee under Trust No. 5780, and EVERETT HOWELL, the present owner of the subject property and/or obligor under the Note, hereinafter called Second Party, WITNESSETH:

AND, WHEREAS, the parties hereto wish to modify the terms of said Note and Mortgage by modifying the mode of payments to monthly and by extending the maturity date thereof to March 14, 1992.

NOW THEREFORE, in consideration of ONE DOLLAR, the covenants contained herein, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- As of the date hereof, the principal amount due under the Note is \$4,600.00.
- The quarterly installments of principal and interest in the amount of \$800.00 shall be changed to monthly installments of principal and interest in the amount of \$800.00, beginning on October 14, 1991, and continuing on the 14th day of each month thereafter until the entire amount due is paid, except that all sums due, if not sooner paid, shall be due and payable on March 14, 1992.
- The maturity date of the Note and Mortgage hereinbefore described shall be extended from August 14, 1991 to March 14, 1992.
- In all other respects, the Note and Mortgage hereinbefore described shall remain unchanged and in full force and effect.
