The owner or owners of any tract or tracts of land, contiguous to an existing fire protection district, may file a written petition to the trustees of the fire protection district to which they seek to have their tract or tracts of land attached, containing a definite description of the boundaries of the territory and a statement that they desire that their property become a part of the fire protection district to which their petition is addressed, and that they are willing that their property assume a proportionate share of the bonded indebtedness, if any, of such fire protection district.

and

WHEREAS, the territory described hereinafter is outside of but is contiguous to the Country Club Hills Fire Protection District; and

WHEREAS, a written petition, under oath, signed by all of the owners of record of the land hereinafter described, in Exhibit "A", a copy of which is attached hereto, has been filed with the secretary of the Country Club Hills Fire Protection District; requesting that said territory be annexed to the Country Club Hills Fire Protection District; and

WHEREAS, said land is not within the corporate limits of any lex-supported fire protection service; and

WHEREAS, the Board of Trustees of the Country Club Hills Fire Protaction District have duly considered said petition and find and believe it would be in the best interests of the said fire protection district that said territory be annexed to the Country Club Hills 7 ire Protection District;


