ORDINANCE PERTAINING TO THE ANNEXATION OF TERRITORY TO THE COUNTRY CLUB HILLS FIRE PROTECTION DISTRICT, COOK COUNTY, ILLINOIS

ORDINANCE 0-3-91

WHEREAS, the Country Club Hills Fire Protection District is a fire protection district organized and existing under the provisions of the Illinois Revised Statutes, Ch. 127 1/2, approved July 8, 1927 and amended; and

WHEREAS, Sec. 127 1/2 of said Illinois Revised Statutes, ch. 23, provides, in part, as follows:

The owner or owners of any tract or tracts of land, contiguous to an existing fire protection district, may file a written petition to the trustees of the fire protection district to which they seek to have their tract or tracts of land attached, containing a definite description of the boundaries of the territory and a statement that they desire that their property become a part of the fire protection district to which their petition is addressed, and that they are willing that their property assume a proportionate share of the bonded indebtedness, if any, of such fire protection district.

and

WHEREAS, the territory described hereinafter is outside of but is contiguous to the Country Club Hills Fire Protection District; and

WHEREAS, a written petition, under oath, signed by all of the owners of record of the land hereinafter described, in Exhibit "A", a copy of which is attached hereto, has been filed with the secretary of the Country Club Hills Fire Protection District; requesting that said territory be annexed to the Country Club Hills Fire Protection District; and

WHEREAS, said land is not within the corporate limits of any tax-supported fire protection service; and

WHEREAS, the Board of Trustees of the Country Club Hills Fire Protection District have duly considered said petition and find and believe it would be in the best interests of the said fire protection district that said territory be annexed to the Country Club Hills Fire Protection District;

Section 1: That all of the land and territory legally described in Exhibit "A", a copy of which is attached hereto and made a part hereof, be and the same is hereby annexed to the Country Club Hills Fire Protection District, Cook County, Illinois. An accurate map of said territory is attached hereto and made a part hereof.

Section 2: That the secretary of the Country Club Hills Fire Protection District is hereby authorized and directed to file a certified copy of this ordinance, together with an accurate map of the annexed territory herein described, in the Offices of the County Clerk of Cook County, Illinois and the County Recorder of Cook County, Illinois.

Section 3: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 4: That the owner of record of the land herein annexed is commonly known as the LUTHERAN HOME FOR THE AGED/SOUTH COOK COUNTY GIRL SCOUTS, INC.

EXHIBIT A

A PARCEL OF LAND IN THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SECTION 33, TOWNSHIP 36 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF THE INDIAN BOUNDARY LINE, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHEAST CORNER OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33. THENCE WEST ALONG THE NORTH LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33, A DISTANCE OF 936.00 FEET; THENCE IN A SOUTHWESTERLY DIRECTION ALONG A LINE MAKING AN ANGLE OF 73 DEGREES 15 MINUTES 01 SECOND TO THE LEFT OF THE LAST DESCRIBED COURSE EXTENDED A DISTANCE OF 939.00 FEET; THENCE SOUTHERLY ALONG A LINE MAKING AN ANGLE OF 11 DEGREES 53 MINUTES 40 SECONDS TO THE LEFT OF THE LAST DESCRIBED COURSE EXTENDED A DISTANCE OF 427.00 FEET TO A POINT IN THE SOUTH LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33 THE SAID POINT BEING 1242.00 FEET WEST OF THE EAST LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33; THENCE EAST ALONG THE SAID SOUTH LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33 TO THE EAST LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33, A DISTANCE OF 1242.00 FEET; THENCE NORTH ALONG SAID EAST LINE OF THE NORTH WEST 1/4 OF THE SOUTH EAST 1/4 OF SAID SECTION 33, A DISTANCE OF 1325.90 FEET TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.

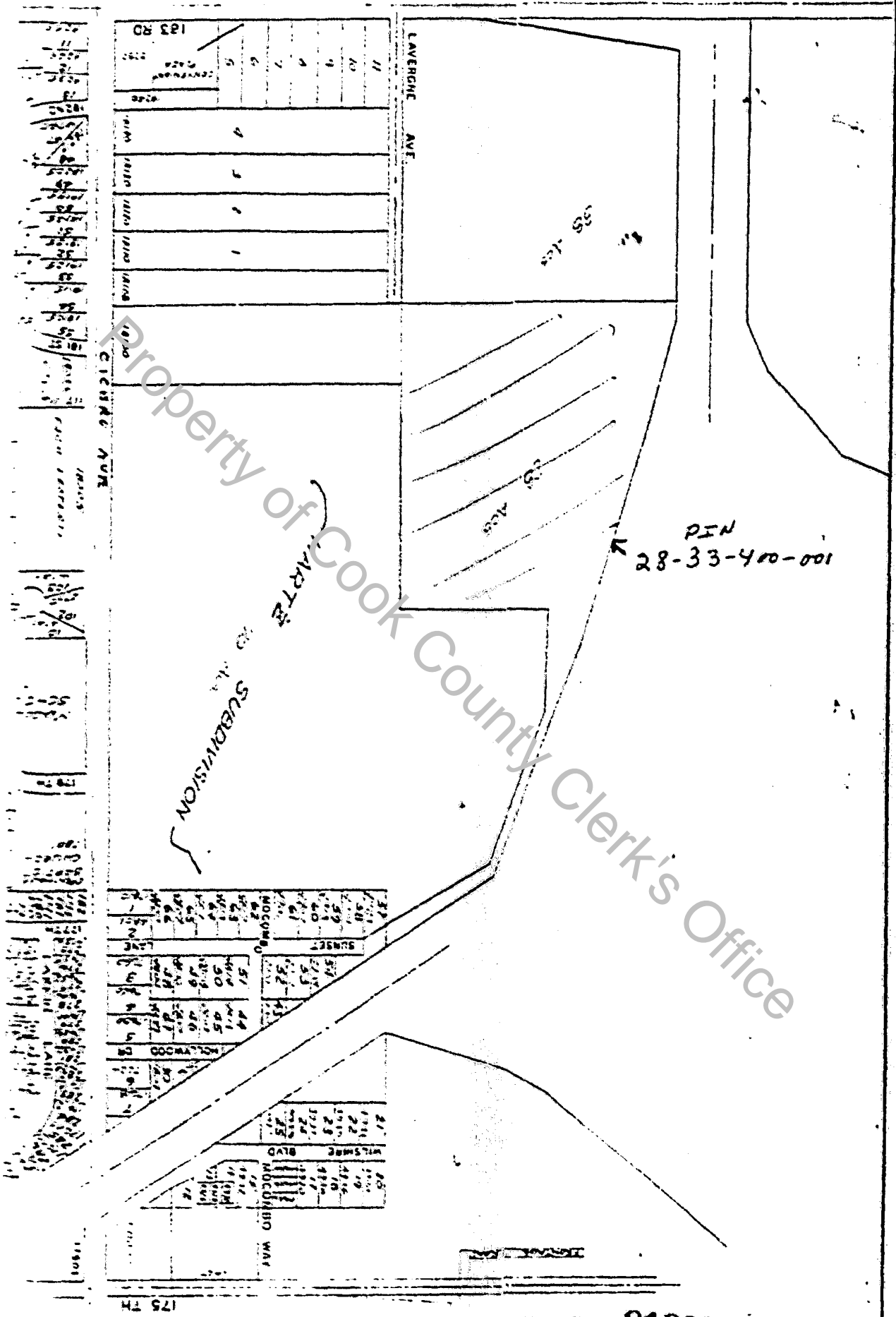
