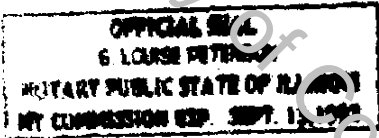

LEGAL DESCRIPTION

Lot 1 in Highland Development Company's Consolidation in the Northwest fractional quarter of fractional Section 7, Township 41 North, Range 14, East of the Third Principal Meridian, in the City of Evanston, in Cook County, Illinois, and also that part of the Chicago, Evanston and Lake Superior Railroad Company's right of way (now the Chicago Transit Authority Company's right of way), situated in the fractional West half of Section 7, Township 41 North, Range 14, East of the Third Principal Meridian described as follows: Commencing at the Northeast corner of Lot 12 in Frank P. Holmes Subdivision, so that part of the Northwest fractional quarter of fractional Section 7 Township 41 North, Range 14, East of the Third Principal Meridian, lying West of the center line of Ridge Road and East of the right of way of the Chicago, Evanston and Lake Superior Railroad (now Chicago Transit Authority Company right of way), thence West on the North line of said Lot 12 and its extension West (also being the South line of Central Street) 524.08 ft., more or less, to its intersection with the East right of way line of said Chicago, Evanston, Lake Superior Railroad Company, and the point of beginning, thence South 23°22'20" East along said right of way line, 136.22 ft., thence West 14.60 ft., thence North 23°22'20" West 43.75 ft., thence South 26°27'40" West 4.50 ft., thence North 23°22'20" West 88.30 ft., thence North 1°12'48" East 3.78 ft. to the South line of Central Street aforesaid, thence East 17.78 ft. on the South line of Central Street aforesaid to the point of beginning, in Cook County, Illinois.
