4. The claimant has completed performance of his contract in that he has delivered all lumber and materials required under the contract to the site of the improvements on the property described herein.

5. There is now justly due and owing the claimant, after allowing to the owner all credits, deductions, and set-offs, Twenty One Thousand Two Hundred Forty Seven and 98/100 (\$21,247.98) Dollars, which is still due and unpaid.

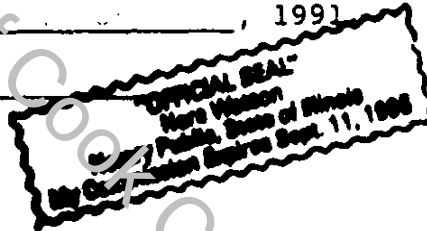

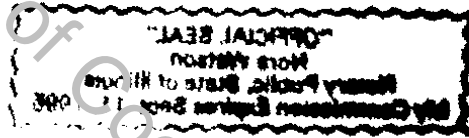
