THIS MORTGAGE is made this 12TH day of JUNE 1981 between the Mortgagor, GEORGE A. 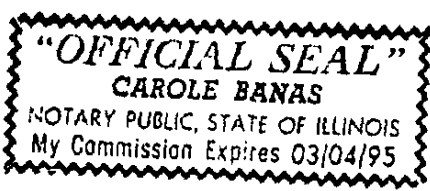
