MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on OCTOBER 2ND 1986. The mortgagor is JEREMIAH D. WILLIAMS, SR. and SAUNDRA E. WILLIAMS; HIS WIFE ("Borrower"). This Security Instrument is given to CLYDE FEDERAL SAVINGS AND LOAN ASSOCIATION, which is organized and existing under the laws of THE UNITED STATES OF AMERICA, and whose address is 7222 WEST CERMAK ROAD, NORTH RIVERSIDE, IL 60546 ("Lender"). Borrower owes Lender the principal sum of ***SEVENTY-FIVE THOUSAND EIGHT HUNDRED AND 00/100*** Dollars (U.S. \$ 75,800.00). For this purpose, Borrower does hereby mortgage, grant and convey to Lender the following described property located in COOK County, Illinois:
