ASSIGNMENT OF MORTGAGE/DEED OF TRUST

WHEREAS, on December 7, 1989, Arlington Heights Federal Savings and Loan Association ("Old Arlington") was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5(d) (2) (A) of the Home Recovery and Enforcement Act of 1989 by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"), and immediately appointed the Resolution Trust Corporation as Receiver of Old Arlington;

WHEREAS, on December 7, 1989, the OTS by order number 89-455 and 89-456, chartered Arlington Heights Savings Association, F.A. ("New Arlington") as a federal mutual savings bank and pursuant to Section 5(d) (2) (B) (i) of the Home Owners Loan Act of 1933 ("HOLA"), appointed the Resolution Trust Corporation Conservator for New Arlington;

WHEREAS, the Receiver transferred the assets and certain liabilities of Old Arlington to New Arlington, including certain mortgage/deeds of trust which are subject to this Assignment, pursuant to a Purchase and Assumption agreement dated November 16, 1990;

WHEREAS, on November 16, 1990, the OTS, by order No. 90-1800 and 90-1801, appointed the RTC as the Receiver for New Arlington; and

NOW THEREFORE, the Resolution Trust Corporation as Receiver of Arlington Heights Savings Association, F.A. for value received does hereby grant, sell, assign, transfer, set over and convey to UMBIC-ONE, INC.,

("Assignee"), its successors and assigns WITHOUT RE COURSE, REPRESENTATION OR WARRANTY in interest the Assignor may have in a mortgage/deed of trust dated November 2, 1984 made by Ronald P. Murray and Judith E. Murray, as mortgagors/borrowers, recorded on November 13, 1984 in the Record of Mortgages/Deeds of Trust, Book/VOLUME/Liber: , Page/Folio: , Document Number: 27332232 in the Office of the Recorder/Register of Deeds/Chancery Court of Cook County, which said mortgage/deed of trust is secured by a parcel of land commonly known as: 932 Carlton, Skokie, Illinois, 60193, (Legal Description, if required, is attached).
