EXTENSION AGREEMENT

This AGREEMENT entered into this 3rd day of December, 1991 by and between ERWIN SCHLOSS, A WIDOWER, NOT SINCE REMARRIED, hereinafter called "MORTGAGOR", and THE FIRST NATIONAL BANK OF LINCOLNWOOD, hereinafter called "MORTGAGEE":

WITNESSETH:

WHEREAS, on JANUARY 6, 1987 MORTGAGOR executed a Equity Agreement and Disclosure and a First Credit Equity Line Mortgage for a Line of Credit in the amount of THIRTY FIVE THOUSAND AND 00/100.....DOLLARS (\$35,000.00) payable on JANUARY 5, 1992, said Equity Line Mortgage of even date therewith to MORTGAGEE and recorded on JANUARY 9, 1987 in the office of the RECORDER OF DEEDS in the County of COOK, State of Illinois, as Document No. 87016434; covering the following described premises:

LOT 12 AND THE NORTH 10 FEET OF LOT 13 IN BLOCK 8 IN DEMPSTER CRAWFORD MANOR, A SUBDIVISION OF THAT PART OF THE NORTH WEST 1/4 OF SECTION 23, TOWNSHIP 41 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN LYING WESTERLY OF EAST PRAIRIE ROAD (EXCEPT THE SOUTH 17-1/2 CHAINS THEREOF) ACCORDING TO THE PLAT THEREOF RECORDED AS DOCUMENT NO. 9025818 IN COOK COUNTY, ILLINOIS.

WHEREAS, the Line of Credit comes due on January 5, 1992, and

WHEREAS, the MORTGAGOR has requested that the due date of said Line of Credit be extended, which request has been granted by the MORTGAGEE, and

WHEREAS, MORTGAGEE, under the Equity Line Mortgage described above has agreed to this extension.

NOW THEREFORE, it is hereby agreed by and between said MORTGAGOR and MORTGAGEE that the full amount of all unpaid loans and interest outstanding under MORTGAGOR'S Line of Credit as set forth in the EQUITY AGREEMENT AND DISCLOSURE and the FIRST CREDIT EQUITY LINE MORTGAGE shall be extended to JANUARY 5, 1999.

All of the provisions of the EQUITY AGREEMENT AND DISCLOSURE and the FIRST CREDIT EQUITY LINE MORTGAGE shall remain in full force and effect and be binding on the Parties hereto except as herein expressly modified.

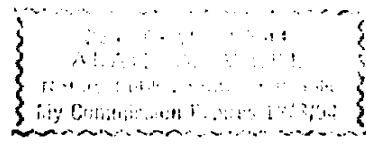
