## RELEASE OF ASSIGNMENT OF LESSEE'S INTEREST IN LEASE





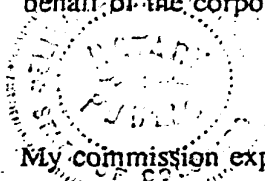
