and the same with interest thereon from date of payment at Eighteen Per Cent (18%) per annum shall be so much additional indebtedness secured hereby

In the event of a breach of any of the aforesaid covenants or agreements, the whole of said indebtedness, including principal and all earned interest, shall, at the option of the legal holder thereof, without notice, become immediately due and payable, and with interest thereon from time of such breach at Eighteen Per Cent (18%) per annum, shall be recoverable by foreclosure thereof, or by suit at law, or both, the same as if all of said indebtedness had then matured by the express terms.

It is agreed by the Grantor that all expenses and disbursements paid or incurred in behalf of plaintiff in connection with the foreclosure hereof--including reasonable attorney's fees, outlays for documentation evidence, stemographer's charges, cost of procuring or completing abstract showing the whole title of said premises embracing foreclosure decree shall be paid by the Granton, and the like expenses and disbursements, occasioned by any suit or proceeding wherein the highten or any holder of any indebtedness, as such, may be a party, shall also be paid by the Clanton.
