13. Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. 15. Governing Law: Severability. This Security Instrument shall be governed by federal law and the lawe the jurisdiction in which the Property is located. In the event that any provision or clause of this Security Instrument or thNote conflicts with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note whicean be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note articulared to

be severable.

16. Borrower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.

17. Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any intest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural perant without Lender's prior written consent. Lender may, at its option, require immediate payment in full of all sums secured by this Struirity Instrument. 20. Hazardous Substances. Borrower shall not cause or per nit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower shall not do, nor allow amone else to do, anything affecting the Property that is in violation of any Environmental Law. The preceding two server ces shall not apply to the presence, use, or storage on the Property of small quantities of Hazardous Substances that are generally recognized to be appropriate to normal residential uses and to maintenance of the Property.

Borrower shall promptly give Lender written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private party involving the Property and any Hazardous Substance or Environmental Law of which Borrower has actual knowledge. If Borrower learns, or is notified by any governmental or regulatory authority, that any removal or other remediation of any Hazardous Substance affecting the Property is necessary. If the default is not cured on or before the date specified in the notice.
