WITNESSETH:

WHEREAS, the Declaration of Condominium for Hidden Lake Estates Condominium was recorded April 29, 1980 as document number 25439399 and subsequent thereto the following Amendments containing various changes and additions to the property were recorded as follows:

WHEREAS, in the 3rd Amendment heretofore identified, in part provided for a modification of the original section 8A of the Declaration reducing the voting rights of unit 14 from 2 votes to 1 vote while still erroneously maintaining the double interest in the common elements which cannot be done under the provisions of the Condominium Act.

WHEREAS, it was the intention of the Condominium Association and the Developer to submit all remaining property within the original developmental area of the condominium project to the act under the provisions of the original Condominium Declaration which required final submission of the parcels no later than April 11, 1990 and,

WHEREAS, the Association was of the belief that all of the units designated, plus provision for the addition of the land for units 9, 10, 19, 20, 31A, 51, 52, 53 and their respective percentages, 1 through 53 (except 47 and 48), had been submitted to the Declaration by the 12th developer's Amendment and,

The Board or Managers by a vote of at least two-thirds approving this action desires to correct the following condominium property development and create the unit interests and percentages as follows in Exhibit "A" attached hereto, eliminating from the plats proposed units that were included in error.
