



ORDINANCE NO. ____91-0-072

AM ORDINANCE ANNEXING PROPERTY 191ST STREET AND OAK PARK AVENUE (WORLD MUSIC TREATER)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

gection 1: That this President and Board of Trustees find as
follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be aimaged to the Village of Tinley Park, Cook and Will Countles, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed ky all owners of record of all the land within the territory, there being no electors residing within or on said territory;
- (c) That there is no highway adjacent to or located within the aforesaid territory which is under the jurisdiction of any Township or its Commissioner of Highways, and therefore no notice of the proposed annexation has been served upon and given to any Commissioner of Highways or Board of Town Auditors;
- (d) That the territory is not located within any public library district or fire protection district and therefore no notice has been given to any library district or fire protection district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the comporate limits of any municipality, but is contiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.

<u>Section 2:</u> That the following described territory be and is hereby annexed to the Village of Tinley Park, Cook and Will Counties, Illinois:

The South East 1/4 of the South West 1/4 South of the Indian Boundary Line of Section 6, Township 35 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois.

<u>Section 3:</u> That the Village Clerk is hereby and herewith instructed to record with the Recorder of Deeds of Cook County, Illinois, and to file with the County Clerk of Cook County, Illinois:

(a) a copy of this Ordinance certified as correct by the Clerk of said Village of Tinley Park; and

(b) a plat of the land included in this annexation, as required by law, said plat to be attached to the aforesaid certified copy of this Ordinance.

<u>Section 4:</u> That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
