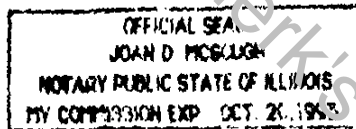

## EXHIBIT A

### Legal Description

That part of the Northeast Quarter of Section 21, Township 41 North, Range 9 East of the Third Principal Meridian, described as follows: Commencing at the Northeast corner of said Section; thence Westerly along the North line of said Section 21, a distance of 673.12 feet to the East line of the West Half of the East Half of the Northeast Quarter of said Section 21; thence Southerly along said East line, a distance of 349.68 feet to the Southerly right of way line of Schaumburg Road as conveyed to the County of Cook by Deed dated May 12, 1947 and recorded May 26, 1947 as Document No. 14064447 for a point hereinafter known as Point "A"; thence Southwesterly along said right of way 15.68 feet to a point of curve; thence Westerly along said right of way being on a curve to the right and having a radius of 1451.79 feet and arc distance of 281.26 feet for the point of beginning; thence South 02 degrees 04 minutes 58 seconds West along a line 279.0 feet West of and parallel to the East line of West Half of East Half of said Northeast Quarter, a distance of 731.74 feet to a point that is 832.0 feet South of said Point "A" (as measured perpendicular to and along said East line); thence North 87 degrees 55 minutes 02 seconds West 3.0 feet; thence South 02 degrees 04 minutes 58 seconds West along a line that is 282.0 feet West of and parallel to said East line of West half of East Half of Northeast Quarter 745.50 feet; thence South 87 degrees 55 minutes 02 seconds East 282.0 feet to said East line; thence South 02 degrees 04 minutes 58 seconds West along said East line 765.29 feet to the South line of said Northeast Quarter; thence North 90 degrees 00 minutes 00 seconds West along said South line 1330.11 feet; thence North 02 degrees 03 minutes 41 seconds East 2260.23 feet to the South line of Schaumburg Road; thence South 86 degrees 55 minutes 39 seconds East 674.66 feet to a point of curve; thence Easterly along said right of way, being on a curve to the left and having a radius of 1451.79 feet, an arc distance of 380.0 feet to the point of beginning; containing 58.8586 Acres, in Cook County, Illinois.
