LEGAL DESCRIPTION PARCEL A

That part of Lot 23 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereto recorded December 29th, 1988 as Document No. 88598270 described as follows: Commencing at the Northwest corner of said Lot 23; thence North 70 degrees 50 minutes 00 seconds East along the Northerly line of said Lot 23 a distance of 187.48 feet for a place of beginning; thence continuing North 70 degrees 50 minutes 00 seconds East along the Northerly line of said Lot 23 a distance of 19.85 feet; thence South 11 degrees 55 minutes 23 seconds West 168.69 feet to a point a curve, being the Southerly line of said Lot 23; thence Westerly along the arc of said curve, being concave to the North, being the Southerly line of Lot 23, having a radius of 220.00 feet, having a chord bearing of North 82 degrees 26 minutes 15 seconds West for a distance of 17.05 feet; thence North 11 degrees 55 minutes 23 seconds East 159.74 feet to the place of Beginning; said parcel of land herein described containing 0.064 acres, more or less, in Cook County, Illinois.
