You covenant that you are lawfully served of the estate hereby conveyed and have the right to mortgage, grant and convey the Property and that the Property is unencum erid, except for encumbrances of record. You, unless you are an Illinois land trust, warrants and will defend generally the falls of any Property against all claims and demands, subject to any encumbrances of record.

Covenants. You and we covenant and agree as fodows:

1. Payment of Principal and Interest. You shall promptly pay when due by the terms of the Agreement the principal of and interest accrued on the indebtedness evidenced by the Agreement, together with any other fees, charges or premiums imposed by the Agreement or by this Mortgage.

2. Line of Credit Loan. This Mortgage secures a Line of Credit Loan Agreement. You will enjoy access to that Line of

Credit during the term bereof.

3. Agreed Periodic Payments. During the term hereof, you agree to pay on or before the payment due date shown on each periodic Billing Statement the Minimum Payment Due for that Billing Cycle (each Billing Cycle will be approximately one month). The payment due date for each Billing Cycle is approximately (senty to 1,25) days after the close of the Billing Cycle. If, on the Maturity Date, you still owe amounts under the Agreement, you will pay those amounts in full on the Maturity

- 4. Finance Charges. You agree to pay interest (a "Finance Charge" ) of the Outstanding Principal Balance of your Preferred Line Account as determined by the Agreement. You agree to pay more that the Annual Percentage Rate of 14,4000 %.
- 5. Application of Payments. Unless applicable law provides otherwise, all payments received by us under the Agreement and this Mortgage shall be applied as provided in the Agreement. Charges incurred prosuant to paragraph 7 hereof will be treated as Finance Charges for purposes of application of payments only

6. Charges; Liens. You shall pay all taxes, assessments, charges, lines and impositions of ributable to the Property which may attain priority over this Mortgage, and leasehold payments or grounds tents, it any. You shad promptly furnish to us

receipts evidencing these payments.

7. Protection of Our Rights in the Property: Mortgage Insurance. It you tail to perform the covenants and agreements contained in this Mortgage, or there is a legal proceeding that may significantly affect our reguls in the property (such as a proceeding in bankruptcy, probate, for condemnation or to enforce laws or Regulations), then we may do and pay for whatever is necessary to protect the value of the Property and our rights in the Property. Our action may include paying any sums secured by a lien which has priority over this Mortgage, appearing in court, paying reasonable attorneys' fees and entering on the Property to make repairs. Although we may take action under this paragraph 7, we do not have to do so.

Any amounts disbursed by us under this paragraph 7 shall become additional debt of yours secured by this Mortgage. Unless you and we agree to other terms of payment, these amounts shall bear interest from the date of disbutsement at the rate

provided in the Agreement and shall be payable, with interest, upon notice from us to you requesting payment.

8. Borrower Not Released; Forebearance by Us Not a Waiver. Extension of the time for payment of modification of amortization of the sums secured by this Mortgage granted by us to any successor in interest of yours shall not operate to release the liability of the original Preferred Account Holder's or your successor in interest. We shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Mortgage by reason of any demand made by the original Account Holder or Account Holder's successors in interest. Any forebearance by us in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.

9. Successor and Assigns Bound; Joint and Several Liability; Co-Signers. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of you and us, subject to the provisions of paragraph 12. Your covenants and agreements shall be joint and several. Any Mortgagor who co-signs this Mortgage but does not execute the Agreement: (a) is co-signing this Mortgage only to mortgage, grant and convex that Mortgagor's interest in the Property under the terms of this Mortgage; (b) is not personally obligated to pay the sums secured by this Mortgage; and (c) agrees that we and any other Mortgagor may agree to extend, modify, forebear or make any accommodations with regard to the terms of this Mortgage or the Agreement without that Mortgagor's consent. Such a Mortgagor is identified below by executing this Mortgage as an "other owner" of the Property.

If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to properly for the benefit or use of its members of shareholders, the Property also includes Borrower's interest in the Owner association and the uses, proceeds and benefits of Borrower's interest.

CONDOMINIUM COVE ONTS. In addition to the covenants and agreements made in the Security Instrument.

Borrower and Lender further covens ac and agree as follows:

A. Condominium Obligations, Byrtower shall perform all of Bortower's obligations under the Condominium Project's Constituent Documents, The "Constituent Documents" are the: (1) Declaration or any other document which creates the Condominium Project; (ii) by-laws; (iii) code at regulations; and (iv) other equivalent documents. Borrower shall promptly pay, when due, all dues and assessments imposed pursuant to the Constituent Documents.

B. Hazard Insurance, So long as the Omer's Association maintains, with a generally accepted insurance carrier, a "master" or "blanket" policy on the Condomin.ur. Project which is satisfactory to Lender and which provides insurance coverage in the amounts, for the periods, and again the hazards Lender requires, including fire and hazards included within the term "extended coverage," then:

Borrower's obligation under Paragraph 4 to main his and insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owrers association policy

Borrower shall give Lender prompt notice of any lapse in required hazard insurance coverage.

In the event of a distribution of lazard insurance proceed. it lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to Borrower are hereby assigned and shall be paid to Lender for application to the sums secured by the Security Instrument, with any sixess paid to Borrower.

C. Public Liability Insurance, Borrower shall take such actions as may be teasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to Lender.

D. Condemnation. The proceeds of any award or claim for damages. As et or consequential, payable to Borrower in connection with any condemnation or other taking of all or any part of the Property, whether of the unit or of the common elements, or for any conveyance in lieu of condemnation, are hereby assigned and mall be paid to Lender. Such proceeds shall be applied by Lender to the sums secured by the Security Instrument as provided in Paragraph 8.

E. Lender's Prior Consent, Borrower shall not, except after notice to Lender and with Lender's prior written consent, either partition or subdivide the Property or consent to:

(i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty of in the case of a taking by condemnation or entirent domain:

(ii) any amendment to any provision of the Constituent Documents at the provision is for the express benefit of Lender;

(iii) termination of professional management and assumption of self-management of the Corrers Association; or

(iv) any action which would have the effect of rendering the public liability insurance coverage maintained by the Owners Association unacceptable to Lender.

F. Remedles. If Borrower does not pay condominum dues and assessments when due, then Lender may pay them. Any amounts disbursed by Lender under this paragraph F shall become additional debt of Botrower secured by the Security Instrument. Unless Borrower and Lender agree to other terms of payment, these amounts shall bear interest from the date of disbursement at the rate provided in the Preferred Line Agreement and shall be payable, with interest, upon notice from Lender to Borrower requesting payment

10. Prior Martgages. (4) title to

your home, the Property, is transferred as more fully described in paragraph 12 below; or (8) any of you die.

(b) If you are in default under the Agreement or this Mortgage, we may terminate your Preferred Line Account and require you to pay immediately the principal balance outstanding, any and all interest you may owe on that amount, together with all other fees, costs or premiums charged to your account. The principal balance outstanding under the Agreement after default shall continue to accrue interest until paid at the rate provided for in the Agreement as if no default had occurred. In addition to the right to terminate your Preferred Line Account and declare all sums immediately due and owing under the Agreement, in the event of a default, we shall have the right to refuse to make additional Loans to you under the Agreement (reduce your Credit Limit). If we refuse to make additional Loans to you after default, but do not terminate your account, you must notify us in writing if you would like to obtain further Loans and can demonstrate that the condition that led to the default no longer explos

12. Transfer of the Property.
