LOAN MODIFICATION AGREEMENT

THIS AGREEMENT dated December 5, 1990, by and between Harris Bank Hinsdale, National Association ("Lender"); and Hyun T. Oh and Cecilia J. Oh, Husband and Wife ("Borrowers"), witnesseth:

WHEREAS, Lender has agreed to lend Borrowers the principal amount of Three hundred nineteen thousand one hundred sixty and no/00 dollars (\$319,160.00) evidenced by a promissory note dated December 5, 1988, and secured by a Mortgage dated December 5, 1988, recorded December 27, 1988, with the Cook County Recorder of Deeds, as Document No. 88-592428, mortgaging, granting, and conveying to Lender the property legally described as:

Lot 5 in McDiarmid and Palumbo's "Longwood", being a resubdivision of Lot 3 in Eastview Acres Subdivision in Section 18, and Lot 1 in Vickery's Maybrook Acres in Section 19, together with vacated 63rd Street adjacent to said Lot, all in Township 38 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

WHEREAS, said note is due and payable and the parties wish to extend the Maturity date of the note:

WHEREAS, the parties hereto agreed to extend the maturity date to December 5, 1990 as recorded in a loan modification agreement dated December 5, 1989 and recorded in the recorder's office of Cook County on January 29, 1990 as document No. 90046407.

NOW, THEREFORE, the parties hereto agree to extend the Maturity date of the mortgage and note to December 5, 1991 and the Borrowers shall make monthly payments of interest due. The parties further agree that the outstanding principal balance of Two hundred forty six thousand three hundred ninety seven dollars and 59/100 (\$246,397.59) shall bear interest at the rate of Prime plus one percent, floating.

In all other respects, the parties hereto reconfirm and ratify the provisions of the original mortgage and note.
