MORTGAGE MODIFICATION AGREEMENT

THIS AGREEMENT is made this 7th day of January, 1991, by and between Commercial National Bank of Berwyn ("bank"), the owner of the note and mortgage hereinafter described, and Zoran M. Djordjevic and Dobrila Djordjevic, his wife(J), representing themselves to be the owners of the real estate hereinafter and in said mortgage described ("owner").

In consideration of the mutual promises of the parties hereto, the parties hereby agree to increase the line of credit amount to \$ 20,000.00 in the note or notes of COMMERCIAL NATIONAL BANK OF BERWYN dated April 2nd, 1990 ("note"), secured by a mortgage ("mortgage") recorded on April 11, 1990, in the office of the recorder of deeds of Cook County, Illinois, as document No. 90164125 conveying to the bank certain real estate in Cook County, Illinois, described as follows:

The South half of lot 104 and all of lot 105 in Frank H. Hathaways Addition to Morton Park a subdivision of blocks 6 and 7 in T. F. Baldwin's Subdivision of the North West Quarter of Section 33, Township 39 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

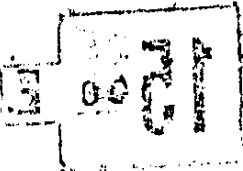

This agreement is supplementary to the Mortgage. All provisions of the Mortgage and Note, including the right to declare principal and accrued interest due for any cause specified in the Mortgage or Note, shall remain in full force and effect. The terms and conditions of this Agreement shall control in the event of any inconsistency between this Agreement and the Note or Mortgage. The Owner agrees to perform all the covenants of the grantor or grantors in the Mortgage. The provisions of this Agreement shall inure to the benefit of any holder of the Note and shall bind the heirs, personal representatives and assigns of the Owner. This Agreement shall be governed and construed in accordance with the laws of the State Of Illinois. The Owner hereby waives and releases all rights and benefits accruing under and by virtue of any and all statutes of the State Of Illinois providing for the exemption of homesteads from sale on execution or otherwise and all other interests in the above described real estate, including, without limitations, and exemptions the Owner may have under any state or federal bankruptcy or insolvency laws in the above described real estate.

This loan is payable in full on March 2nd, 1995. At maturity, you must repay the entire principal balance of the loan and unpaid interest then due. The Bank is under no obligation to refinance the loan at that time. You will, therefore, be required to make payment out of other assets that you may own, or you will have to find a lender, which may be the bank you have this loan with, willing to lend you the money. If you refinance this loan at maturity, you may have to pay some or all of the closing costs normally associated with a new loan even if you obtain refinancing from the same bank.

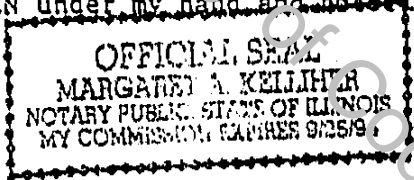

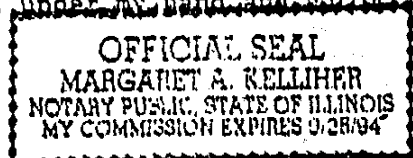
