The Comer hereby waives and releases all rights and benefits accruing under and by virtue of any and all statutes of the State Of Illinois providing for the exemption of nomesteads from sale on execution or otherwise and all other interests in the above described real estate, including, without limitations, and exemptions the Owner may have under any state or federal bankruptcy or insolvency laws in the above described real estate.

This loan is payable in full on March 2nd, 1995. At maturity, you must repay the entire principal balance of the loan and unpaid interest then due. The Bank is under no obligation to refinance the loan at that time. You will, therefore, be required to make payment out of other assets that you may own, or you will have to find a lender, which may be the bank you have this loan with, willing to lend you the money.
