MORTGAGE AND ASSIGNMENT OF RENTS

THIS MORTGAGE (the "Mortgage") is made as of December 3/.
1990 by and between LaSalle National Trust, N.A., as Trustee under Trust Agreement dated December 3/, 1990 and known as Trustee Number 116013 (the "Mortgagor"), with offices at 135 Sour. LaSalle Street, Chicago, Illinois 60690, and Jerome Fins servicing agent for those certain payees under notes all as more completely described in Exhibit B attached because (1773) completely described in Exhibit B attached hereto, "Mortgagee", with offices at c/o Geneva Real Estate Corp., N. Clark Street Suite 610, Chicago, 60610.

WITMESSETH:

WHEREAS, the sole beneficiary of the Mortgagor is KJP partnership, a Wisconsin general partnership (the "Beneficiary") and the Beneficiary is listly indebted to those parties more specifically set forth in Exhibit B attached hereto ("Noteholders") in the aggrigate principal sum of \$500,000.00 evidence by those certain Promissory Notes of Beneficiary dated pagement 17, 1991 (collectively the "Notes" or the "Note"), made payable to the order of and delivered to the Noteholders whereby the Beneficiary promised to pay the said principal sum, late charges, and interest at the rate and in installments, all as provided in the Note. The final nayment of principal and interest, if not sooner paid, shall be due on harmalia 1844. The Notes rank pari passu with each ther. That certain Note Administration Agreement executed between Mortgagee and the Noteholders on [1, 1990 authorizes Mortgagee to act on behalf of the Noteholders as set forth traveln. All payments on account of the Indebtedness (as that telm is hereinafter defined) secured nereby shall be applied first to interest on the tunpaid principal balance, secondly to any other sums due thereunder, thirdly to all other advances and sums secured hereby, and the remainder to principal, all of said principal and interest being made payable at such place as the lolder of the Note may from time to time in writing appoint, and in the absence of such appointment, then at the office of the Mortgageel and sole peneficiary of the Mortgagor Note may from time to time in writing appoint, and in the absence of such appointment, then at the office of the Mortgagee, and

WHEREAS, to secure the Note, the Mortgagee has required that the Beneficiary direct the Trustee to cause this Mortgage to be duly executed in Eavor of Mortgagee.

which, with the property hereinafter described, is collectively referred to herein as the "Premises."

TOGETHER with all improvements, tenements, reversions remainders, easements, fixtures and appurtenances now or hereafter thereto belonging, and all rents, issues and profits thereof for so long and during all such times as Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily); all tenant security deposits, utility deposits and insurance premium rebates to Mortgagor may be entitled or which Mortgagor may be holding; all shades, awnings, venetian blinds, screens, screen doc , storm doors and windows, stoves and ranges, refrigerators, curtain fixtures, partitions and attached floor covering now or hereafter therein or thereon, and all fixtures, apparatus equipment and articles now or hereafter therein or thereon us to supply heat, gas, air conditioning, water, light, powe sprinkler protection, waste removal, refrigeration a ventilation (whether single units or centrally controlle including (without restricting the foregoing): all fixtures apparatus, equipment and articles (other than trade fixtures used apparatus, equirment and articles (other than trade fixtures used in the operation of a business and other than inventories held in the operation of a business and other than inventories held for sale) which relate to the use, occupancy, and enjoyment of the Premises; it being understood that the enumeration of any specific articles of property shall in no wise exclude or be held to exclude any items or property not specifically mentioned. All of the land, estate and property hereinabove described, real, personal and mixed, whereof affixed or annexed or not (except where otherwise hereinabove specified) and all rights hereby conveyed and Mortgaged are intended so to be as a unit and are hereby understood, agreed and caclared (to the maximum extent permitted by law) to form part and parcel of the real estate and to be appropriated to the use of the real estate, and shall be, for the purposes of this Mortgage, deemed to be real estate and conveyed and mortgaged hereby.

TO HAVE AND TO HOLD the Premises unto the Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

Maintenance, Repair and Restoration of Improvements, Payment of Prior Liens, etc.

1. Mortgagor shall: (a) promptly repair, restore or rebuild any buildings and other improvements now or baleafter on the Premises which may become damaged or destroyed to substantially the same character as prior to such damage or destruction, without regard to the availability or adequace any casualty insurance proceeds or eminent domain awards; keep the Premises constantly in at least the condition and reas of the date, hereof, without waste: (c) keep the Premises (a) promptly repair. restore keep the Premises constantly in at least the condition and re as of the date, hereof, without waste; (c) keep the Premises see from mechanics' liens or other liens or claims for lien and expressly subordinated to the lien hereof (collectively called "Liens"), subject, however, to the rights of the Mortgagor set forth in Paragraph 1.a. below; (d) immediately pay when due any indebtedness which may be secured by a lien or charge on the Premises on a parity with or superior to the lien hereof, and upon request, exhibit satisfactory evidence of the discharge of such lien to Mortgagee; (e) complete within a reasonable time. building(s) or other improvement(s) now or at any time in proof erection upon the Premises; (f) comply with all federal, state and local requirements of law, regulations, ordinances, orders and judgments and all covenants, easements and restrations of record with respect to the Premises and the use and/or occupancy thereof; g) make no structural alterations in or on the Premises without Mortgagee's prior written consent; (n) observe and comply

with all conditions and requirements (if any) necessary to preserve and extend all rights, easements, licenses, permits (including without limitation zoning variations and any non-conforming uses and structures), privileges, franchises and concessions applicable to the premises or contracted for in connection with any present or future use of the Premises; and (i) pay each item of Indebtedness secured by this Mortgage when due according to the terms hereof and of the Note. As used in this Paragraph 1 and elsewhere in this Mortgage, the term "Indebtedness" means and includes the unpaid principal sum evidenced by the Note, together with all interest and late charges, and all other sums at any time as provided in the Note and secured by this Mortgage.

Right to Contest

1.2. Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any Lien not expressly subordinated to the lien hereof, and defin payment and discharge thereof during the pending of such contest, provided:
(i) that such contest shall have the effect of preventing the sale or forteiture of the Premises or any part thereof, or as interest therein, to satisfy such Lien; (ii) that, within telefication of the premise of the assertion of the days after Mortgagor has been notified of the assertion of such Lien, Mortgagor shall have notified Mortgagee in writing of Mortgagor's intention to contest such Lien, and (iii) that Mortgagor shall have deposited with Mortgagee at such place is Mortgagee, may from time to time in writing appoint, a sure of money which shall be sufficient, in the judgment of the Mortgagee, to pay in full such Lien and all interest which might become due thereon and shall keep on deposit an amount so sufficient at all times, increasing such amount to cover additional interest whenever, in the judgment of the Mortgagee, such increase is advisable. Such deposits, if held by Mortgagee, are to be held without any interest according to the benefit of the Mortgagor or Beneficiary. If Mortgagor shall fail to prosecute such contest with reasonable diligence or shall fail to Mortgagor's intention to contest such Lien, and (iii) that prosecute such contest with reasonable diligence or shall fail to pay the amount of the Lien plus any interest finally determined to be due upon the conclusion of such contest, to the extent such amount exceeds the amount which Mortgagee will pay as provided below, or shall fail to maintain sufficient funds on deposit as bereinabove provided. Mortgagee Tay at the continuation hereinabove provided, Mortgagee may, at its option, apply the money so deposited with Mortgagee in payment of or on account of such Lien, or that part thereof then unpaid together with all interest thereon, if any. If the amount of money so deposited with Mortgagee shall be insufficient for the payment in full of such Lien, together with all interest thereon, Mortgagor shall forthwith, upon demand, deposit with Mortgagee a sum which, when added to the funds then on deposit, shall be sufficient to make such payment in full. Mortgagee shall, upon the final disposition of such contest, apply the money so deposited in full payment of such Lien or that part thereof then unpaid, together with all interest thereon, if any, (provided Mortgagor is not then in default hereunder) when so requested in writing by Mortgagor and when furnished by Mortgagor with sufficient funds to make such payment in full and with evidence satisfactory to to make such payment in full and with evidence satisfactory to Mortgagee of the amount of payment to be made. After such payments, any sums thereafter remaining shall be refunded to Mortgagor.

Payment of Taxes

2. Mortgacor shall pay all general taxes before any penalty or interest attaches, and shall pay all special taxes, special assessments, water charges, sewer service charges, and all other charges against the Premises of any nathe whatsoever then due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor within thirty (30) days following the date of payment. Mortgager shall pay in full "interprotest" any tax or assessment which Mortgagor may desire to contest, in the manner provided by law.

Insurance

5. Mortgagor shall keep all improvements and the Collateral now or hereafter situated on, or used in connection with, said Premises insured against loss or damage by fire on a so-called "All Risks" basis and against such other hazards as may reasonably be required by Mortgagee, including without limitation of the generality of the foregoing: (a) rent loss or business interruption insurance whenever in the opinion of the Mortgagee such protection is necessary; and (b) flood insurance whenever same is available and, in the opinion of Mortgagee, such protection is necessary. Mortgagor shall also provide insurance coverages with such limits for personal injury and death and properly damage as Mortgagee may from time-to-time require. Mortgagee shall have the right to direct that any or all of the limits or coverage of the insurance policies herein described be increased to such amounts as the Mortgagee shall, from time-to-time, in the exercise of its reasonable business judgment deem appropriate. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts satisfactory to Mortgagee, with vaiver of subrogation and replacerent cost endorsements and a standard non-contributory Mortgar clause attached to all policies, including a provision requiring that the coverages evidenced thereby shall not be ter ated or materially modified without thirty (30) days' pri written notice to the Mortgagee and shall name Mortgagee as an auditional insured. Mortgagor shall deliver all original policies, including additional and renewal policies, to Mortgagee and, in the case of insurance about to expire, shall deliver renewal policies not less than thirty (30) days prior to their respective dates of expiration.

Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that require to be maintained hereunder unless Politique is included there is under a standard non-contributory Mortgagee clause acceptable to Mortgagee. Mortgagor shall immediately notify Mortgagee whenever any such separate insurance is taken out and shall promptly deliver to Mortgagee the original policity or policies of such insurance. In the event of a foreclosure of the lien of this Mortgage, or of a transfer of title to the Premises either in lieu of foreclosure or by purchase at the foreclosure sale, all interests in all insurance policies in force shall pass to Mortgagee, transferee or purchaser, as the case may be.

Adjustment of Losses with Insurer and Application of Proceeds of Insurance

6. In case of loss or damage by fire or other rasualty, Mortgagee is authorized: (a) to settle and adjust am claim under insurance policies which insure against such risks; or (b) to allow Mortgagor to agree with the insurance compan, or companies on the amount to be paid in regard to such loss. In either case, Mortgagee is authorized to collect and receipt for any such insurance monies. Such insurance proceeds may: (a) be applied in reduction of the Indebtedness, if Mortgagor is in default under the Note or hereunder or if Mortgagor cannot maintain the escrow hereinafter described; or (b) be held by the Mortgagee and applied to pay for the cost of repair, rebuilding or restoration of the buildings and other improvements on the Premises. If the insurance proceeds are used for repair, rebuilding or restoration or rebuilding, then the Mortgagee agrees to make said proceeds available to reimburse Mortgagor for the cost of repair. The rebuilding or restoration of buildings or other improvements on the Premises provided that such proceeds shall be made available in the manner and under the conditions that the Mortgagee may require; in such event, the buildings and other improvements shall be so repaired, restored or repailt so as to be of at east

equal value and substantially the same character as prior to such damage or destruction. If the proceeds are made available by the Mortgagee to reimburse the Mortgagor or any lessee for the cost of repair, rebuilding or restoration, any surplus, after payment of the cost of repair, rebuilding, restoration and the reasonable charges of the Disbursing Party, as that term is hereinafter defined, shall, at the option of the Mortgagee, be applied on account of the Indebtedness or paid to any party entitled thereto as the same appear on the records of the Mortgagee. If the insurance proceeds are insufficient to repair, restore or rebuild the Premises Mortgagor shall be required to put into escrow an amount of money sufficient to complete the repairing restoration or rebuilding of the Premises in accordance with this paragraph. If Mortgagor cannot maintain such an escrow, Mortgagee may retain the insurance proceeds and apply such proceeds against the Indebtedness, and any excess shall be paid to Mortgagor or any party entitled thereto, without interest, as the same appears on the records of the Mortgagee. No interest shall or allowed to Mortgagor on any proceeds of insurance held by the Disbursing Party.

As used in this Paragraph 6, the term "Disbursing Party" refers to the Mortgagee and to any responsible trust or title insurance company selected by the Mortgagee.

Stamp Tax; Effect of Changes in Laws Regarding Taxation

- 7. If, by the laws of the United States of America or of any state or subdivision thereof having jurisdiction over the Mortgagor, Mortgagee or the Premises, any tax is due or becomes due in respect of the issuance of the Note or any document securing same, the Mortgagor covenants and agrees to pay such tax in the manner required by any such law. The Mortgagor further covenants to reimburse the Mortgagee for any sums which Mortgagee may expend by reason of the imposition of any such tax.
- 7.1 In the event of the enactment, after this date, of any law of the State of Illinois deducting from the value of the land for the purpose of taxation any life thereon, or imposing upon the Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the Indebtedness secured hereby or the holder thereof, then, and in any such event, the Mortgagor, upon demand by the Mortgagee, shall pay such taxes or assessments or reimburse the Mortgagee therefor; provided, however, that if in the opinion of counsel for the such payment; or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law; then and in any such event, the Mortgagee may elect, by notice in writing given to the Mortgagor, to declare all of the Indebtedness to be and become due and payable sixty (60) and from the giving of such notice.

Observance of Lease Assignment

8. As additional security for the payment of the Note and for the faithful performance of the terms and conditions contained herein, Mortgagor has assigned to the Mortgagee all of its rights, title and interest as landlord in and to the leases listed, if any, on the SCHEDULE OF LEASES attached hereto and all future leases of the Premises.

Mortgagor will not, without Mortgagee's prior written consent: (i) execute any assignment or pledge of any rents or any leases of all or are portion of the Premises Except an assignment or pledge seculing the Indebtedness; (ii) accept any payment of any installment of rent more than thirty (30) days before the due date thereof; (iii) modify, alter, amend or in any

way change the terms and provisions of any lease; or (iv) wains the obligation of any tenant under any of the leases to fully and timely perform in strict accordance with the terms thereof.

Mortgagor, at it sole cost and expense, will: (i) at all times promptly discringe and perform all of the covenants, conditions and agreements contained in all leases of the Premises, on the part of the landlord thereunder to be kept and performed; (ii) enforce or secure the performance of all of the covenants, conditions and agreements of such leases on the part of the tenants to be kept and performed; (iii) appear in and defend any action or proceeding arising under, growing out of crin any manner connected with such leases or the obligations, duties or liabilities of the landlord or of any tenants thereunder; (iv) transfer and assign or cause to be separately transferred and assigned to Mortgagee, upon written request of Mortgagee, any lease or leases of the Premises or any portition thereof hereafter entered into, and make, execute and deliver to Mortgagee upon demand, any and all instruments required to effectuate said assignment; (v) furnish Mortgagee, within ten (10) days after a request by Mortgagee so to do, a written statement containing the names of all tenants and the terms of all leases of the Premises, including the spaces occupied and the rentals payable thereunder; and (vi) exercise within five (5) days of any decand therefor by Mortgagee any right to request from the tenant under any lease of the Premises, a certificate with respect to the Status thereof.

Nothing in this Mortgage or in any other documents relating to the Note shall be construed to obligate Mortgages, expressly or by implication, to perform any of the covenants of any landlord under any of the leases assigned to Mortgages or to pay any sum of money or camages therein provided to be paid by the landlord, each and all of which covenants and payments Mortgagor agrees to perform and pay or cause to be performed and paid.

At the option of the Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in eminent domain), to any one or more leases affecting any part of the Premises, upon the execution by Mortgagee and recording or registration thereof, at any time hereafter, in the office wherein this Mortgage was registered or filed for record, of a unilateral declaration to that effect.

In the event of the enforcement by Mortgagee of any remedies provided for by law or by this Mortgage, the tenant under each lease of the Premises shall, at the option of the Mortgagee (but provided automatic attornment is provided for in each such lease), attorn to any person succeeding to the interest of landlord as a result of such enforcement and shall recognize such successor-in-interest as landlord under such lease without change in the terms or other provisions thereof; provide however, that said successor-in-interest shall not be bound any payment of rent or additional rent for more than one month advance or any amendment or modification to any lease many without the consent of Mortgagee or said successor-in-interest. Each tenant, upon request by said successor-in-interest, shall execute and deliver an instrument or instruments confirming such attornment.

Mortgagee shall have the option to declare this Mortgage in default because of material default of landlord in leases of the Premises whether or not such default is cured by Mortgagee pursuant to the right granted herein. It is covenanted and agreed that a default under any Assignment of Rents and Leases execute, pursuant to this Paragraph 8 shall constitute a default hereunder, on account of which the whole of the Indebtedness shall at once, at the option of the Mortgagee, become immediately due and payable, without notice to the Mortgager.

Mortgagor and Lien Not Released

9. From time to time Mortgagee may, at Mortgagee's option, without giving notice to or obtaining the consent of Mortgagor of Mortgagor's successors or assigns or the consent of any guarantor or tenant, without liability on Mortgagee's part and notwithstanding Mortgagor's breach of any covenant, agreement or condition: (a) release anyone primarily or secondarily liable on any of the Indebtedness; (b) accept a renewal note or notes therefor; (c) release from the lien of this Mortgage any part of the Premises; (d) take or release other or additional security for the Indebtedness.

Any actions taken by Mortgagee pursuant to the terms of this Paragraph 9 shall not impair or affect: (a) the obligation of Mortgagor or Mortgagor's successors or assigns to pay any sums at any time secured by this Mortgage and to observe all of the covenancy, agreements and conditions herein contained; (b) the guaranty of any individual or legal entity for payment of the Indebtedness; and (c) the lien or priority of the lien hereof against the Premises.

Mortgager shall pay to Mortgagee a reasonable service charge and such title insurance premiums and attorneys' fees as may be incurred by Mortgagee for any action described in this Mortgage taken at the request of Mortgagor.

Mortgagee's Performance of Defaulted Acts

10. In case of (efault herein by Mortgagor and same not being cured within the period, if any, hereinbelow provided, Mortgagee may, but need not, make any payment or perform any act herein required of Mortgagot in any form and manner Mortgagee deems expedient, and may, but need not, make full or partial payments of principal or interes; on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said Premises or contest any tax or assessment or cure any default of any landlord in any lease of the Premises. All monies paid for fany of the purposes herein authorized and all expenses paid or incurred in Paragraphs 7 or 7.1 or to protect the Premises or the lien hereof, shall be so much additional Indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at the rate of interest set forth in the Note applicable to a period when a default exists thereunder. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.

Mortgagee's Reliance on Tax Bills, etc.

11. Mortgagee, in making any payment hereby authorized relating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

Acceleration of Indebtedness in Case of Default

of principal or interest on the Note, or any other payment due in accordance with the terms thereof or hereof and such default is not cured within sixty (60) days after written notice of such default having been given to Mortgagor; (b) the Mortgagor or the Beneficiary or any guatantor of the Note shall (1) file a petition of liquidation, reorganization or adjustment or debt under Title 11 of the United States Code (11 U.S.C. §§ 101 et seq.) or any similar law, state or federal, whether now or hereafter existing, or (ii) file any answer admitting insolvency or inability to pay its debts, or (iii) fail to obtain a vacation

or stay of involuntary proceedings within ninety (90) days, as hereinafter provided; or (c) any order for relief of the Mortgagor or the Beneficiary or any guarantor of the Note shall be entered in any case under Title 11 of the United States Code, or a trustee or a receiver shall be appointed for the Mortgagor or Beneficiary or for any guarantor of the Note, or for all or the major part of the property of Mortgagor or Beneficiary or of any guarantor of the Note in any voluntary or involuntary proceeding, or any court shall have taken jurisdiction of all or the major part of the property of the Mortgagor or Beneficiary or of any guarantor of the Note in any voluntary or involuntary proceeding, or any court shall have taken jurisdiction of all or the major part of the property of the Mortgagor or Beneficiary or of any guarantor of the Note in any voluntary or involuntary proceeding, or any court shall have taken jurisdiction of all or proceeding, or any court shall have taken jurisdiction of all or the major part of the property of the Mortgagor or Beneficiary or of any guarantor of the Note in any voluntary or involuntary proceeding for the reorganization, dissolution, liquidation, adjustment of debt or winding up of the Mortgagor or Beneficiary or of any guarantor of the Note and such trustee or receiver shall not be discharged or such jurisdiction not be relinquished or vacated or stayed on appeal or otherwise stayed within ninety (90) days; or [d) the Mortgagor or the Beneficiary or any guarantor of the Note shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay for debts generally as they become due, or shall consent to appointment of a receiver or trustee or liquidator of all or any appointment of a raceiver or trustee or liquidator of all or any major part of its property; or (e) default shall be made in the due observance or performance of any other covenant, agreement or condition hereinbefore or hereinafter contained and required to be kept or performed or observed by the Mortgagor and same is not cured within thirty (30) days after notice thereof from Mortgagee to Mortgagor; (f) default shall be made in the due observance or performance of any covenant, agreement or condition required to be kept or observed by Mortgagor in any other instrument given at performance of any covenant, acreement of condition required to be kept or observed by Mortgager in any other instrument given at any time to secure the payment of the Note and same is not cured within thirty (3D) days after notice thereof from Mortgagee to Mortgagor, then and in any such event, the whole of the Indebtedness shall at once, at the option of the Mortgagee, become immediately due and payable within further notice to Mortgagor.
