RECAPITULATION OF THE DEBTS OF THE COUNTY OF COOK AS OF THE 31ST DAY OF DECEMBER, 1900. The following is a list of the debts of the County of Cook as of the 31st day of December, 1900, as reported by the various departments and agencies of the County.

1. The County of Cook is indebted to the State of Illinois for the purchase of land for the construction of the Cook County Jail, in the amount of \$100,000.00.

2. The County of Cook is indebted to the City of Chicago for the purchase of land for the construction of the Cook County Jail, in the amount of \$50,000.00.
