

AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE LAN OAK PARK DISTRICT
COOK COUNTY, ILLINOIS
PURSUANT TO CHAPTER 105, SECTION 3~10,
OF THE ILLINOIS REVISED STATUTES

WHEREAS, the LAN OAK PARK DISTRICT, Cook County, Illinois, is operating predominantly in the VILLAGE OF LANSING, Illinois; and

WHEREAS, the Board of Commissioners of the LAN OAK PARK DISTRICT is of the orinlon that it would be more beneficial to all persons concerned if the boundaries of the LAN OAK PARK DISTRICT, and the VILLAGE OF LANSING were coterminous, in that said LAN OAK PARK DISTRICT and its recreational facilities could grow and expand as the VILLAGE OF LANSING grows and expands; and

WHEREAS, Chapter 105, Section 3-10, of the Illinois Revised Statutes, provides that whenever a Park District operating within territory predominantly in a village would become coterminous or nearly coterminous with such village upon the annexation of additional territory within such municipalities but not incorporated within a Park District, such Park District may annex such additional territory by the passage of an Ordinance to that effect.
