That on August 15, 1990, said contractor made a subcontract with the claimant to provide complete drywall, acoustical and carpentry work required to add one (2) new door frame and office partitions for and in said improvement, and that on September 1, 1990 the claimant completed thereunder all that was required to be done by said contract. That said contractor is entitled to credits of the value of \$none, leaving due and unpaid and owing to the claimant, after allowing all credits, the sum of ONE THOUSAND SEVEN HUNDRED TEN AND NO/100THS DOLLARS (1,710.00), for which, with interest, the claimant claims a lien on said land and improvements, and on the monies or other considerations due or to become due from the owner under said contract against said contractor, owner and lessee.


