THIS INDENTURE, made JANUARY 24TH 19 91, between

ALFRED HALE AND BRENDA HALE, HIS WIFE AS JOINT TENANTS
herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES INC.
a DELAWARE corporation, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder being herein referred to as Holder of the Note, in the principal sum of 11,702.67
