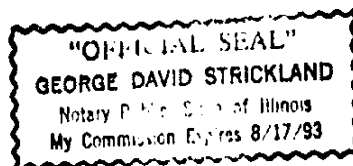

# UNOFFICIAL COPY

That part of the East half of the Northwest Quarter of Section 13, Township 46 North, Range 10 East of the Third Principal Meridian, in Lake County, Illinois, described as follows:

Commencing at the intersection of the West line of the East half of the Northwest Quarter of Section 13 aforesaid, with the North right of way line of Illinois Route 173 as dedicated per document Number 374484 recorded October 23, 1931; thence on an assumed azimuth of 359 degrees 56 minutes 59 seconds along said West line, a distance of 200.00 feet for a point of beginning; thence on an azimuth of 89 degrees 56 minutes 59 seconds, a distance of 141.05 feet to a point on the West right of way line of US Route 45 as dedicated per Document Number 251903 recorded June 30, 1930; thence on an azimuth of 346 degrees 37 minutes 27 seconds along said West right of way line, a distance of 386.11 feet to a point of curvature; thence along said right of way line and curve, concave easterly, radius 2904.90 feet, central angle 05 degrees 37 minutes 51 seconds, a distance of 285.48 feet to a point of the aforementioned West line of the East half of the Northwest Quarter of Section 13 which is 156.29 feet North of the point of beginning; thence on an azimuth of 179 degrees 56 minutes 09 seconds along said West line, a distance of 656.29 feet to the point of beginning.
