RECITALS

A. Fairmont Federal Savings Association, Fairmont, Minnesota ("Association"), is a federally-chartered mutual savings association, the accounts of which are insured by the Federal Deposit Insurance Corporation, for which the Resolution Trust Corporation is Conservator.

B. Pursuant to § 5(d)(2)(H)(ii) of the Home Owners' Loan Act of 1933 ("HOLA"), as amended by § 301 of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989 ("FIRREA"), the Director of the Office of Thrift Supervision ("Director") shall appoint only the Federal Deposit Insurance Corporation or the Resolution Trust Corporation, as appropriate, as receiver for a savings association for the purpose of liquidation or winding up the affairs of such savings association.

ORDER

The Director, upon consideration of the administrative record, hereby replaces the Conservator for the Association with the Resolution Trust Corporation as Receiver for the Association for the purpose of liquidation, pursuant to subdivision (F) of § 5(d)(2) of HOLA, as amended, effective upon the surrender of possession of the Association by the Conservator to the Receiver.
