- 2) That the quantity of water was approximately 111 thousand cubic feet.
- 3) That the amount due for water service is \$762.96.
- 4) That sewer service was furnished to the herein described property by the Claimant, at the rate as provided by Chapter 185.1 of the Municipal Code of the City of Chicago.
- 5) That the amount due for sewer service is \$595.10.
- 6) That the total amount due the Claimant therefore is \$1,358.06.

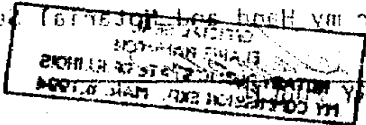
(9) That as of this date said owner, titleholders or parties are not entitled to any credits or amount leaving due, unpaid, and owing to the Claimant the amount claimed herein.
