FIRST SPECIAL AMENDMENT TO DECLARATION OF COMMON OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE COURTS OF NORTHBROOK

WHEREAS, Declarant was the original holder of record title to certain real estate located in the Village of Northbrook, County of Cook, State of Illinois, which is learly described on Exhibit "A" attached hereto and hereby made a part of and which is the subject of the above mentioned Declaration; and,

WHEREAS, Article X, Paragraph R, reserves to the Declarant and/or Developer the right to make Special Amendments to the Declaration if required by any governmental entities; and,

WHEREAS, the Village of Northbrook has required that the Declaration be amended to provide for the operation, replacement and maintenance of a traffic control signal and related appurtenances (the "Signal"), which may be installed at the entrance to the Development and which solely services the Development.

NOW, THEREFORE, the Declarant and Developer do hereby amend the Declaration in the following respects:

1. That Article VI be amended by adding the following provision to said Article:

RESOLUTION NO. 91-R-26

Optima Townhomes Limited Partnership and American National Bank and Trust Company of Chicago, not individually but as Trustee under a Trust Agreement dated May 1, 1987 and known as Trust Number 102401-09 (collectively referred to as the "Applicant") have received rezoning and a special use to permit a planned residential development on an approximately 15.64 acre parcel located on the south side of Lake-Cook Road, immediately west of Northbrook Court Shopping Center in the Village of Northbrook. The planned residential development, known as The Courts of Northbrook, consists of 104 townhome units and common open space on one zoning lot.

On January 24, 1989, the Board of Trustees approved the Declaration of Common Ownership and of Easements, Restrictions, Covenants and By-Laws for The Courts of Northbrook (the "Declaration") in Resolution No. 89-R-8. Since that time, the Applicant has igreed to formalize its commitment to amend the Declaration to provide that if a traffic control signal is constructed at the intersection of Avon and Lake-Cook Roads, the development will be responsible for the operation, repair, replacement and maintenance of and supply of electricity to the signal. Money for construction of the signal, if warranted, has been placed in escrow by the Applicant by separate agreement. The attached First Special Amendment to the Declaration has been reviewed by and is acceptable to the Village Attorney.

NOW, THEREFORE, BE IN RESOLVED by the President and Board of Trustees of the Village of Northbrook, County of Cook and State of Illinois, THAT:

Section 1.

The First Special Amendment to Declaration of Common Ownership and of Easements, Restrictions, Covenants and By-Laws for The Courts of Northbrook is hereby approved.

Section 2.

The Village Manager is hereby authorized and directed to cause the attached Declaration to be recorded in the Office of the Cook County Recorder of Deeds.
