WHEREAS, the Developer has reserved the right to add Additional Lands (as defined in the First Amendment) as part of the property subject to the terms and conditions of the Declaration; and

WHEREAS, the First Illinois Bank and Trust has a mortgage lien on the Property or hereinafter defined;

NOW, THEREFORE, the Declaration is hereby amended to add the following described property to the Property (as that term is defined in the Declaration) and that upon recordation of this Fourth Amendment, such property will be subject to the terms and conditions and entitled to all rights and benefits contained in the Declaration and all amendments thereto:

Lot One (1) in the Timberlake Estates Subdivision being a subdivision of the Northeast corner of Section 15, Township 42 North, Range 10 East of the Third Principal Meridian in the Village of Palatine in Cook County, Illinois.
