ADDITIONAL CONVENANTS. INCORPORATED THEREIN BY REFERENCE

- 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic on other liens or claims for lien not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgagee or to holder of the contract; (4) complete within a reasonable time any buildings now or at any time in process of crection upon said premises; (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof. (6) make no material alterations in said premises except as required by law or municipal ordinance
- 2. Mortgagors shall pay before any penalty attaches all general taxes and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall upon written request, furnish to Mortgager or to holders of the contract duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now and hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured bereby, all in companies satisfactory to the holders of the contract under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies including additional and renewal policies to holder of the contract and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Mortgagee or the holder of the contract may, but need not, make any payment or perform any net hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax here or other prior here or title or claim thereof, or redeem from any tax encumbrances, if any, and purchase, discharge, compromise or series any tax the forther prior fed in the or claim the colling as a safe or forteiture, after the safe prepared in connection therewith, including attorneys fees, and any other moneys advanced by Morigagee or the holders of the contract to protect the morigaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and pegable without notice. Inaction of Morigagee or holders of the contract shall never be considered as a walver of any right accruing to them on account of any default hereunder on the part of the Morigagors.
- 5. The Mortgagee or the hyder of the contract hereby secured making any payment hereby authorized relating to taxes and assessments, may do so according to any bill, statement of estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any car assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall pay each item (a ir debtedness berein mentioned, when due according to the terms hereof. Such appointment may be made either before or after sale without notice, without regard to the sole of the premises or whether the same shall be then occupied as a homestead or not and the Morigages hereunder may be appointed as such receiver. Such receiver shall have power to the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency during the fully latent to the rents, issues and profits and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period.
