

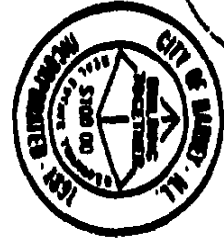

America, bidder by Assignment, Grantee

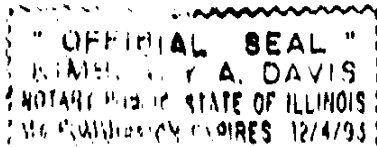
WHEREAS, the premises hereinafter described having been duly
