

Sec. 6321. Lien For Taxes

If any person liable to pay any tax neglects or inflate to noy the same after demand, the amount (including any interest, additional amount, addition to tax, or assersable penety, together with any costs that may accrue in addition thereto; shall be also in favor of the United States upon all property and rights to property, whether real or personal, belonging to such personal
