This cause coming before this Court upon the petitions for attorney fees of Thomas W. Nutter pursuant to 40 Ill. Rev. Stat § 508 (1987) and other statutes and rules which have been given, the parties being present and represented by counsel, Thomas W. Nutter representing himself, the parties through counsel having stipulated to the Court to admit their evidence by representations of the evidence, the Court hearing and considering the evidence and arguments of counsel, the Court having considered the law on the matter makes the following findings:

A. Thomas W. Nutter pursuant to a voided employment agreement charged \$150.00 for Court time, \$125.00 for office time and \$55.00 for paralegal time.

B. The exhibits attached to the petitions for fees reflect a reasonable use of time and labor and expense. The amount charged reflects the novelty and difficulty of the questions involved, and the skill required to perform the legal service properly. The amount charged reflects a proper consideration of the likelihood that the acceptance of the particular employment would preclude other employment by the lawyer; and it reflects the fee customarily charged in the locality for similar legal services.

C. The amount charged reflects a proper consideration of the amount involved and the results obtained; the time limitation imposed by the Court and the circumstances; the nature and length of the professional relationship with the client; and the experience, reputation, and ability of the lawyer performing the services.

D. The Court finds that the services were calculated on time allotments to the tenth of the hour and the expenses were charged at the amounts incurred.

E. The equities are against assessing fees and costs of Thomas W. Mentis against Heiter Demonte.

D. The amount required is to be reduced only because the Court finds that Eileen Demonte has the ability to pay \$20,000.00 toward the unpaid balance of her fees and costs and no more.

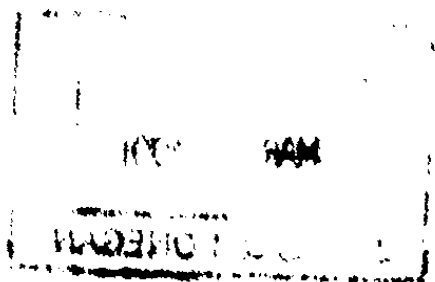
