all interest in and to the following described real estate, situated in the County of Cook, in the State of Illinois, to-wit:

Lot 15 in C.B. Simon's Resubdivision of Block 20 in E. Simon's Original Subdivision of the South East 1/4 of Section 35, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, Commonly known as: 1620 N. St. Louis, Chicago, Illinois.

\* This quitclaim deed is subject to the express condition that the property be developed within five (5) years of the conveyance in accordance with the provisions of the Chicago Housing Authority Scattered Site Program set forth in Gautreaux v. Chicago Housing Authority, 304 F. Supp. 736 (N.D. Ill., 1969). In the event that the condition is not satisfied by the grantee, the grantor may re-enter and take possession of the property and terminate the estate conveyed by this quitclaim deed, and such title, rights and interests of the grantee shall revert to the grantor. The grantor's right of re-entry and reverter shall terminate upon the completion of the improvements in accordance with the above condition and the issuance of a certificate of occupancy by the grantor.

Further, the grantee shall maintain the property in a safe condition and keep it free of debris. Further subject to covenants, zoning and building restrictions, easements and conditions and ALL GENERAL REAL ESTATE TAXES OF RECORD.

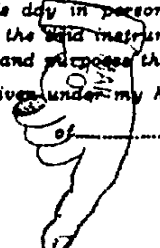
