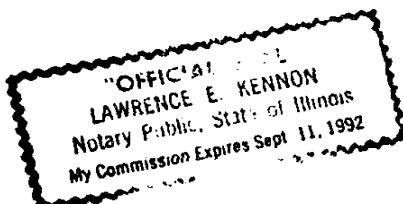

That part of the Southeast quarter of the Southwest quarter of Section 8, Township 42 North, Range 11 East of the Third Principal Meridian, described as follows:

Commencing at the Southwest corner of the Southeast quarter of the Southwest quarter of Section 8, thence North along the West line of said Southeast quarter of the Southwest quarter a distance of 785.32 feet to a point of beginning; thence East parallel with the South line of said Section 870.63 feet more or less to a point in the Northerly extension of the East line of Lot 4 in Arlington Vista, a Subdivision of the South 38 rods of the East half of the Southwest quarter and the South 38 rods of the West half of the South east quarter of said Section 8, thence North along said line 265.68 feet, thence West parallel with the South line of said Section 870.35 feet more or less to the West line of said South line of said Southeast 1/4 of the South West 1/4; then South along said line 265.68 feet to the point of beginning in Cook County, Illinois.
