REPORT OF THE COMMISSIONERS

THE COMMISSIONERS OF THE DEPARTMENT OF SOCIAL SERVICES have the honor to submit to the Senate the report of the Department for the year ending December 31, 1949. This report contains a summary of the work of the Department during the year and a statement of the financial condition of the Department at the close of the year.

The Department of Social Services is a part of the State Government and is responsible for the administration of the State's social welfare programs. The Department's activities are directed by the Commissioner, who is appointed by the Governor. The Department is organized into several divisions, each of which is headed by a Deputy Commissioner. The divisions are: Administration, Child Welfare, Family Services, Hospital and Health Services, Public Welfare, and Vocational Rehabilitation.

The Department's budget for the year ending December 31, 1949, was \$100,000,000. The actual expenditures for the year were \$98,000,000. The Department's assets at the close of the year were \$10,000,000 and its liabilities were \$2,000,000. The Department's net assets at the close of the year were \$8,000,000.

The Department's work during the year was characterized by a steady increase in the number of cases under its jurisdiction. The total number of cases at the close of the year was 1,000,000, an increase of 10% over the number of cases at the close of the previous year. The Department's expenditures for the year were also an increase of 10% over the expenditures for the previous year.
