2. That the title holder of record is ALFREDO LOPEZ, divorced and not since remarried.

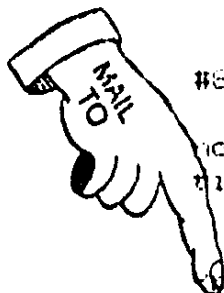
