ASSIGNMENT OF RENTS

THIS ASSIGNMENT OF RENTS IS DATED MARCH 15, 1991, between Clyde L. Webb and Roberta Webb, his wife, whose address is 4360 signe Harbor Dr., Hoffman Estates, IL. 60195 (referred to below as "Grantor"); and Suburban National Bank of Felatine, whose address is 50 North Brockway Street, Palatine, IL 60067 (referred to below as "Lender").

ASSIGNMENT. For valuable consideration, Grantor assigns and conveys to Lender all of Grantor's right, little, and interest in and to the Rents from the following described Property located in Cook County, State of Illinois:

The Real Property or its address is commonly known as 4350 Stone Harbor Dr., Hoffman Estates, IL 60195. The Rual Property tax identification number is 02-19-320-019.

DEFINITIONS. The following words shall have the following meanings when used in this Assignment. Terms not otherwise defined in this Assignment shall have the meanings attributed to such terms in the Uniform Commercial Code. All references to dollar amounts shall mean amounts in tawful money of the United States of America.

Assignment. The word "Assignment" means this Assignment of Ronte between Gracies and Lander, and includes without limitation all assignments and security interest provisions relating to the Rents.

Borrower. The word "Borrower" means Altra Tel Communications incorporated.

Event of Default. The words "Event of Default" mean and include any of the Events of Default set Icrin below in the section tilled "Events of Dolault."

Grantor. The word "Grantor" means any and all persons and entities executing this Assignment, including witness limitation all Grantors named above. Any Grantor who signs this Assignment, but does not sign the Note, is signing this Assignment only to count and convey that Grantor's interest in the Real Property and to grant a security interest in Granton's Interest in the Rents and Personal Property is Lender and is not personally liable under the Note except as otherwise provided by contract or law.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any amounts our ended or advanced by Londer to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Assignment, together with interest on such amounts as provided in this Assignment.

Lander. The word "Londer" means Suburban National Bank of Palatine, its successors and assigns.

Note. The word "Note" means the promissory note or credit agreement dated March 15, 1991, in the original principal amount of \$236,117.73 from Borrower to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is a variable interest rate based upon an Index. The index currently is 9,000% per annum. The interest rate to be applied to the unpaid principal balance of this Assignment shall be at a rate of 2,000 percentage point(s) over the Index, resulting in an initial rate of 11.000% per annum. NOTICE: Under no circumstances shall the interest rate on this Assignment be more than the maximum rate allowed by applicable law.

Property. The word "Property" means the real property, and all improvements thereon, described above in the "Assignment" section.

Real Property. The words "Real Property" mean the property, interests and rights described above in the "Property Definition" section.

Related Documents. The words "Related Documents" mean and include without limitation all promissory notes, credit agreements, loan agreements, guaranties, security agreements, mortgages, deeds of trust, and all other instruments and documents, whether now or hereafted excepted to connection with Research Indicated Indica existing, executed in connection with Borrower's Indebtedness to Lander.

Rents. The word "Rents" means all rebits, revenues, income, issues, and profits from the Property, whether due now or later, including without limitation all Rents from all leases described on any exhibit attached to this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF ANY AND ALL OBLIGATIONS OF GRANTOR AND BORROWER UNDER THE NOTE AND THIS ASSIGNMENT. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON THE **FOLLOWING TERMS:**

GRANTOR'S WAIVERS. Granter waives all rights or detenses arising by reason of any "one action" or "anti-deficiency" law, or any other law which may prevent Lender from bringing any action against Granter, including a claim for deficiency to the extent Lender is otherwise entitled to a claim for deficiency, before or after Lender's commencement or completion of any foreclosure action, either judicially or by exercise of a power of sale.

GRANTOR'S REPRESENTATIONS AND WARRANTIES. Grantor warrants that: (a) this Assignment is executed at Borrower's request and not at the request of Lender; (b) Grantor has the full power and right to enter into this Assignment and to hypothecate the Property; (c) Grantor has established adequate means of obtaining from Borrower on a continuing basis information about Borrower's financial condition; and (d) Lender has made no representation to Grantor about Borrower (including without limitation the creditworthiness of Borrower).

BORROWER'S WAIVERS AND RESPONSIBILITIES. Lender need not tell Borrower about any action or fraction Lender takes in connection with this Assignment. Borrower assumes the responsibility for being and keeping Informed about the Property. Borrower waives any defenses that may arise because of any action or fraction of Lender, including without limitation any failure or Lender to realize upon the Property, or any delay by Lender in realizing upon the Property. Borrower agrees to remain liable under the Note with Lender no matter what action Lender takes or fails to take under this Assignment.

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment, Borrower shall pay to Lender all amounts secured by this Assignment as they become due, and shall strictly perform all of Borrower's obligations. Unless and until Lender exercises its right to collect the Rents as provided below and so long as there is no default under this Assignment, Granter may remain in possession and control of and operate and manage the Property, and collect the Rents.

LENDER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect an are point the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Leade may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Linear's agent.

Enter the Property. Lender may often upon and take possession of the Property; domand, collect and receive from the tenants or from any other persons liable therefor, all of the Plants; material and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons non-the Property.

Maintain the Property. Lendor may enter upon the Property to maintain the Property and keep the earns in repair; to pay the costs thereof and of all services of all employees, including their or tipm int, and of all continuing costs and expenses of maintaining the Property in proper repair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on fire and other insurance effected by Lander on the Property.

Compliance with Laws. Lender may do any and all thing, to execute and comply with the taws of the State of Illinois and also all other laws, rules, orders, orders, orders and requirements of all other governments affecting the Property.

Lease the Property. Londer may rent or lease the whole or my part of the Property for such form or terms and on such conditions as Luncer may does appropriate.

Employ Agents. Lender may engage such agent or agents as Lender may deem appropriate, either in Lender's name or in Granter's name, to runt and manage the Property, including the collection and application of Kents.

Other Acts. Lender may do all such other things and acts with respect to the Property as Lender may deem appropriate and may act exclusively

and solely in the place and stead of Granter and to have all of the powers of Creater for the purposes stated above.

No Requirement to Act. Lander shall not be required to do any of the foregoing acts or shings, and the fact that Lander shall have purformed one or more of the foregoing acts or things shall not require Lander to do any other specific act of thing.

APPLICATION OF RENTS. All costs and expenses incurred by Lander in connection with the Property shall be to Berrower's account and Lander may pay such costs and expenses from the Rents. Lander, in its sole describen, shall determine the application of any and all Plants received by it; however, any such Rents received by Lander which are not applied to such costs and expenses shall be applied to the Indebtedness. All expenditures made by Lander under this Assignment and not reimbursed from the Rents shall become a part of the In a bledness secured by this Assignment, and shall be payable on demand, with interest at the Note rate from date of expenditure until paid.

FULL PERFORMANCE. If Grantor pays all of the Indobtedness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment and the Note, Lender shall execute and deliver to Grantor a suitable satisfaction of this Assignment and the statements of termination of any financing statement on tile evidencing Lender's security interest in the Rents and the Property. Any fermination for required by law shall be paid by Grantor, if permitted by applicable law.

EXPENDITURES BY LENDER. If Granter tails to comply with any provision of this Assignment, including any obligizion to maintain Existing Indubtedness in good standing as required below, or if any action or proceeding is commenced that would materially affect Lender's interests in the Property. Lender on Granter's behalf may, but shall not be required to, take any action that Lender deems appropriate. Any amount that Lender expends in so doing will bear interest at the rate charged under the Note from the date incurred or paid by Lender to the date of repayment by Granter. All such expenses, at Lender's option, will (a) be payable on demand. (b) be added to the balance of the Note and be apportioned among and be payable with any installment payments to become due during either (i) the term of any applicable insurance policy or (ii) the remaining term of the Note, or (c) be treated as a balloon payment which will be due and payable at the Note's maturity. This Assignment also will secure payment of those amounts. The rights provided for in this paragraph shall be in addition to any other rights or any remodes to which Lender may be entitled on account have had.

DEFAULT. Each of the following, at the option of Londor, shall constitute an event of default ("Event of Default") under this Assignment:

Default on Indebtedness. Failure of Bonower to make any payment when due on the Indebtedness.

Compliance Default. Failure to comply with any other form, obligation, covenant or condition contained in this Assignment, the Note or in any of the Related Documents. If such a lailure is curable and if Granter or Borrower has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) months, it may be cured (and no Event of Default will have occurred) if Granter or Borrower, after Lander sends written notice demanding cure of such failure: (a) cures the failure within fifteen (15) days; or (b) if the cure requires more than fifteen (15) days, immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or turnished to Lander by or on behalf of Grantor or Berrower under this Assignment, the Note or the Related Documents is, or at the time made or turnished was, false in any material respect.

Other Defaults. Fallure of Granter or Borrower to comply with any turm, obligation, covenant, or condition contained in any other agreement between Granter or Borrower and Lender.

Insolvency. The insolvency of Granter or Borrower, appointment of a receiver for any part of Granter or Borrower's property, any ausignment for the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency laws by or against Granter or Borrower, or the dissolution or termination of Granter or Borrower's existence as a going business (if Granter or Borrower is a business). Except to the extent prohibited by federal law or fillingly law, the death of Granter or Borrower is fillingly also shall constitute an Event of Delault under this Assignment.

Foreclosure, etc. Commoncoment of foreclosure, whether by judicial proceeding, self-help, repossession or any other method, by any craditor of Grantor against any of the Property. However, this subsection shall not apply in the event of a good faith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure, provided that Grantor gives Lender written notice of such claim and furnishes reserves or a surely bond for the claim satisfactory to Lender.

Events Affecting Guarantor. Any of the preceding events occurs with respect to any Guarantor of any of the Indobtedness or such Guarantor dies or becomes incompetent. Lender, at its option, may, but shall not be required to, permit the Guarantor's estate to assume unconditionally the obligations arising under the guaranty in a manner satisfactory to Lender, and, in doing so, cure the Event of Default.

Insecurity. Lender reasonably deems itself insecure.

Existing Indebtedness. Default of Granter under any Existing Indebtedness or under any instrument on the Property securing any Existing Indebtedness, of commencement of any suit or other action to foreclose any existing tien on the Property.

RIGHTS AND REMEDIE'S ON DEFAULT. Upon the occurrence of any Event of Default and at any lime thereafter, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebteomers. Lender shall have the right at its option without notice to Borrower to declare the entire Indebtedness immediately due and payable, including any recognised penalty which Borrower would be required to pay.

Collect Rents. Lender shall have the right, without notice to Granter or Borrower, to take possession of the Property and collect the Rents, including amounts past due and univaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness. In furtherance of this right, Lender may require any renant or other user of the Property to make payments of rent or use fees directly to Lender. If the Rents are collected by Lender, then Granter interestibly designates Lender as Granter's attentions-in-fact to andorse instruments received in payment thereof in the name of Granter and to negotiate the right and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Mortgages in Possession. Londer shall have the right to be placed as mortgages in possession or to have a receiver appointed to take possession of all or any part of the Property, with the possession of the Property, with the possession of collect the Bonts from the Property and Locky the proceeds, over and above the cost of the receivership, against the Indebtedness. The mortgages in possession or receiver may serve without bond if permitted by law. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditure, or take action to perform an obligation of Granter or Benevier to perform shall not under this Assignment after failure of Granter or Benevier to perform shall not under this Assignment.

Attorneys' Fees; Expenses. If Lender institutes any suit or action to enforce any or 1'.0 forms of this Assignment, Lender shall be entitled to recover attorneys' fees at trial and on any appeal. Whether or not any court action is involver, all reasonable expenses incurred by Lender that in Lender's opinion are necessary at any time for the protection of its intensit or the enforcement of 1'.5 rights shall become a part of the indebtudness payable on demand and shall bear interest from the date of expenditure until repaid at the note rate. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's alterneys fees and logal expenses whether or not there is a lawsuit, including atterneys' fees for bankruptcy proceedings (including efforts to modify or vacate 2'.9 automatic stay or injunction), appeals and any anticipated post-judgment collection services, the cont of searching records, obtaining little reports (including forcelesure reports), surveyors' reports, and appraisal fees, and title insurance, to the extent permitted by applicable law. No alteration of or amendment to this Assignment shall be effective unless given in writing and signed by the parties sought to be charged or bound by the alteration or amendment.

Applicable Law. This Assignment has been delivered to Lender and accepted by Lender in the State of Illinois. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois.

Multiple Parties; Corporate Authority. All obligations of Grantor and Borrown under this Assignment shall be joint and several, and a relevences to Grantor shall mean each and every Grantor, and all references to Borrown shall mean each and every Borrown. This means that each of the persons signing below is responsible for all obligations in this Assignment. Where any one or more of the Grantor or Borrowns are corporations or partnerships, it is not necessary for Lander to inquire into the powers of any of the Grantor or Borrowns or of the officers, directors, partners, or agents acting or purporting to act on their behalf, and any indebtedness made or created in reliance upon the professed exercise of such powers shall be quaranteed under this Assignment.

No Modification. Granter shall not enter into any agreement with the holder of any mortgage, deed of trust, or other security agreement with the holder of any mortgage, deed of trust, or other security agreement by which that agreement is modified, amended, extended, or renewed without the prior written consent of Lander. Granter shall neither request not accept any luture advances under any such security agreement without the prior written consent of tender.

Severability. It a court of computent jurisdiction linds any provision of this Assignment to be invalid or unenforceable as to any person or circumstances, such finding shall not rander that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be stocken and all other provisions of this Assignment in all other respects shall remain valid and enforceable.

Successors and Assigns. Subject to the firmitations stated in this Assignment on transfer of Granter's interest, this Assignment shall be binding upon and inure to the benefit of the parties, their successors and assigns. If ewnership of the Property becomes vested in a poison other than Granter, Londer, without notice to Granter, may deal with Granter's successors with reference to this Assignment and the Indubtedness by way of

torbearance or extension without releasing Granter from the obligations of this Ausignment or liability under the Indebtedness.
