On or about December 6, 1990, HELLER CONSTRUCTION COMPANY made a contract with claimant wherein claimant was to provide certain carpentry labor, services and equipment for the above described premises for a total value of One Thousand Fifty-Five and no/100 (\$1,055.00) dollars. Said sum is the fair, usual, customary and reasonable value of such materials, supplies and equipment. Claimant has furnished the carpentry services, labor, and equipment required by said contract, all of which were furnished and delivered to and used in and about the improvements of the premises and of the building and other improvements thereon. The last of said carpentry services, labor and equipment

were furnished on or about December 14, 1990.

3. There is now justly due and owing to the claimant for the furnishing of such carpentry services, labor and equipment the sum of One Thousand fifty-five and no/100 (\$1,055.00) dollars which is still due and unpaid. Notice has been given to the owner and parties interested in the manner provided by law not less than 10 days prior hereto. Interest on the unpaid balance is claimed under the statute.

4. Claimant now claims a lien upon the above described property and all improvements thereon against all persons interested and also claims a lien upon the monies or other consideration due from the aforesaid owner to the original contractor, and other parties for the amount of One Thousand fifty-five and no/100 (\$1,055.00) dollars together with interest.

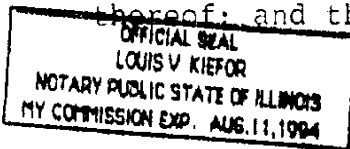
